During the 2024-25 fiscal year Communities In Schools of Palm Beach County provided one touch support to 12,087 students in the School District of Palm Beach County (Tier 1). Intensive one-on-one support (Tier 2 and 3) reached 1,264 students. 94% of these students improved classroom behavior, 93% of our students in 6-11 grade were promoted to the next grade level while 91% graduated. 33% of our students self-reported as homeless and 27% of our students report that they have experienced trauma.
